

Open Letter of Intent: Iverson, Harlan Jacob; visit to Minneapolis, August 2021.

Why write a letter of intent for a visit to relatives? A letter of intent informs negotiations, clarifying points to allow conversations to focus on unique value propositions. For several years I have been the target of escalating actions from a global brand and former employer based on a misunderstanding and met with unreasonable stonewalling or retaliation at each step, which set the stage for systematic discrimination and targeting from a wide range of parties on both sides of the law. I am a lawful person who has operated successfully within the system and have every intention to remain so, continuing to work in legitimate situations allowing for mutually beneficial growth.

Increasingly I've been subject to activity best characterized as "gang stalking"; who would gang up and stalk me? One or more of: a) lawyers of the global brand and associates preventing me from reversing a fraudulently obtained workplace violence protection order (WVPO); b) Big Tech companies stopping a competitor or former employee; c) early friends and relatives who have an opportunity with the pandemic and WVPO to bring me into their service or custody; d) the general hatred and mistrust of homeless people, and our methods like pooping in bags and using threatening looking hardware like the CarPuter in public; e) mistrust of "party people" and "single" men in general, due to past association and incentives; f) former party associates who feel threatened by speech which they perceive as gossip.

My intention is to work at-will and build streams of income through authoring, consulting, and providing low-touch services. Law school is possible; my academics were excellent and I've deep domain experience and could perhaps go full ride, yet need the option to leave. I've worked since age 14, beginning in a grocery store and kitchen. I enjoyed programming and built an early career in web development that progressed for 20 years with a successful tour through academia where I earned a Bachelor's degree in Computer Science. If I'm not free to go work at a corner store then I'm not free to work at-will. Lacking this and with no source of income I must depend on the grace of God to survive. Since early 2021 my father has provided loans on an irregular basis that keep me fed, which may be seen as sufficient to build revenue. This is not enough, as it provides no security—security is Layer two of five in Maslow's hierarchy of needs, and I had operated in a Self Actualized state consistently prior to 2015 when this ordeal began in the employ of OpenTable, and know mental health to be a key ingredient to success and career building. San Francisco provides the right to retreat into my car where I've lived for 3 years—Minneapolis climate extremes make that an untenable arrangement, and so I must return to SF absent safe and secure housing; my father's house is not psychologically safe.

Indeed, my course of action appears unorthodox and perhaps "crazy." The unequivocal message received is "shut up" and "cry me a river;" each party with benefit to be gained by my not directly addressing the WVPO--ie. membership in aforementioned groups a-f. The order was granted with fraudulent information on Apr 20, 2020 in my absence, as the pandemic was heating up and I was starting my prior job at a grocery store. While employed I was required to do online training and did not have IT nor infrastructure outside work to do so, and working while remaining hygienic without running water proved to be physically impossible. Our store was the one in the region with no cases during my employ, and I left for an array of reasons which I expressed to managers on what I felt to be good terms despite the lack of notice. During that period I continued to collect notes and photos of my experience documenting "Urban Camping" and "The Physics of Homelessness"--work I've long deemed important and academic in nature, offering it freely as an open source e-book.

In summary: I am willing and able to work, tho my qualifications and character are under attack and the protection order that was obtained fraudulently and in my absence must be reversed before I can do so freely. Updates may be found on my website at harlanji.com where an RSS feed is available.
